**2. Date of the Hunts:**

All hunts will take place on the Elysian Fields Hunting Preserve between September 1 and January 31 unless otherwise agreed. The time and length of each hunt will be determined by agreement prior to the hunt. A hunt maybe extended if the participant wishes and the extension do not conflicts with other scheduled hunts. **3. Location of Hunt:**

All hunts will take place on property leased by **Elysian Fields Hunting Preserve, LLC**, in Sections 15 and 22 of Bellevue Township, Eaton County, Michigan. The address is **8530 Cronk Highway, Bellevue, Michigan**. The property consists of 380 acres including a 300 acre gun trophy area; and bow and trophy hunting area. Elysian Fields does not have a lodge, thus hunter will need to find accommodation near by, such as Charlotte, Battle Creek, or Bellevue, Michigan. Elysian Fields will be able to arrange accommodations at discounted price if the hunter chooses this option. More than 100 acres within the preserve is farmed, and planted to wheat, corn and soybeans. Farming activities and fence inspections may take place due hunts which may result in more deer activity.

**4. Hunting Fees:**

The **daily hunting fee** is \$200 per day or portion thereof in addition to trophy fees. The **trophy fees** are based on the Safari club International (SCI) gross green score without deductions for asymmetry or non-typical. Please see the attached trophy fee schedule for the actual fee. The sportsman is expected in advance to choose the size of trophy he desires to hunt. The **Booking Fee** in \$1,000.00 due at the time the hunt is booked. The remaining amount is due 30 days before the hunt. The remainder of the fees, if any, will be due at the end of the hunt in cash, certified check, approved check, or money order after the gross green score of the trophy has been determined and before the carcass leaves the premises. Hunting licenses are not required to hunt on a preserve. The hunter will be charged for the trophy taken and the actual number of days hunted. If no trophy is taken, then the hunter will be refunded the paid portion of trophy fee, and thus will pay no trophy fee. The advanced payment less the \$200.00 daily hunting fee will be refunded to the hunter. **Fifty percent (50%) of the advance payment or \$1,000.00, which ever is less, is non-refundable if the hunter fails to appear for the hunt as agreed.**

**5. Guided Hunts:**

All hunts are guided for the safely of the hunter and to assure that the best locations are used and to assisted the hunter in selecting the appropriate size trophy that he is attempting to harvest. The guide will advise the hunter concerning the size of various trophies seen from the stand, but it
