

RELEASE OF LIABILITY, HOLD HARMLESS AND INDEMNIFICATION AGREEMENT

I understand that during my participation in this Hunt I may be exposed to a variety of hazards and risks, foreseen or unforeseen, which are inherent in each Hunt and cannot be eliminated without destroying the unique character of the Hunt. I agree that it is not a necessity for me to hunt or shoot, and I do so voluntarily for my own personal pleasure and entertainment. These inherent risks include, but are not limited to, the dangers of serious personal injury, property damage, and catastrophic injury from exposure to the hazards of firearms or bow and arrow related incidents and the Elysian Fields Hunting Preserve, LLC, has not tried to contradict or minimize my understanding of these risks. I know that injuries and damages can occur by natural causes or activities of other persons, including tripping, stumbling, falling, slipping or climbing into stands. I understand that risks of such injuries and damages are involved in hunting and I appreciate that I may have to exercise extra care for my own person and for others around me in the face of such hazards. I assume full responsibility for staying away from obvious hazards, and all objects that could harm me, whether natural or man made, which are incidental to operation of a hunting preserve, farm or unattended country property.

The Hunt officially begins and ends with entering and leaving Elysian Fields Hunting Preserve, LLC at 8530 Cronk Hwy. Bellevue, Michigan. The Hunt does not include carpooling, transportation, or transit to and from the disclosed location, and I am personally responsible for all risks associated with this travel.

While on Elysian Fields Premises, the hunter shall comply with all Game and Fish laws and regulations of the United States of America, the State of Michigan, and all other appropriate governmental authorities. While on the Elysian Fields Premises, the Hunter shall: (a) observe the rules of safe gun handling; (b) never shoot in the direction of any people, or buildings; (c) leave all gates as the Hunter finds them; (d) use proper care in crossing fences; and (e) not use alcohol or drugs. The hunter will not arrive at Elysian Fields property under the influence of alcohol or drugs. The hunter shall exercise due care not to cause or permit damage or injury to fences, crops, trees, or equipment, and shall not commit or permit waste and damage or injury, and shall not conduct or permit any illegal activity on the Premises.

In consideration for the right to enter the premises of the Preserve, I hereby release and agree to protect, indemnify and hold harmless Elysian Fields Hunting Preserve LLC, and his or her respective agents, employees and assigns from and against any and all claims, demands, causes of action and damages, including attorneys' fees resulting from any accident, incident or occurrence arising out of, incidental to or in any way resulting from the use of the Preserve premises and all improvements thereon. This release applies during the time I am permitted on the Preserve. I hereby further covenant and agree that I, my heirs, successors and assigns will not make any claim or institute any suit or action at law or in equity against the Preserve or his or her respective heirs, agents, representatives, employees, successors or assigns. This Agreement is intended to be as broad and inclusive as is permitted by law. If any provision or any part of any provision of this Agreement is held to be invalid or legally unenforceable for any reason, the remainder of this Agreement shall not be affected thereby and shall remain valid and fully enforceable.

I have read this document in its entirety and I freely and voluntarily assume all risks of such injuries and damages and notwithstanding such risks. I also agree that I have been given the right to seek an attorney's opinion before signing this agreement, and if I have not done so, it is because I have chosen not to do so, and nothing has been said to me verbally or implied in any way, that an attorney's counsel is not necessary. I know attorneys should be consulted before contracts are signed, and this is a contract. I agree to participate in the hunt. To the fullest extent allowed by law, I agree to WAIVE, DISCHARGE CLAIMS, AND RELEASE FROM LIABILITY Elysian Fields Hunting Preserve, LLC, and its officer's any and all liability even if caused by negligence of Elysian Fields Hunting Preserve, LLC. Must be signed by parent if hunter is a minor.
